Re: The Executive Director and PREA Coordinator does comply with PREA National Standards

§115.388 (a) Shamar Hope Haven RTC shall review data collected and aggregated pursuant to §115.387 to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices, and training, including: (1) Identifying problem areas; (2) Taking corrective action on an ongoing basis; and 34 (3) Preparing an annual report of its findings and corrective actions for each facility, as well as Shamar Hope Haven RTC as a whole. (b) Such a report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the agency's progress in addressing sexual abuse. (c) Shamar Hope Haven RTC report shall be approved by the agency head and made readily available to the public through its website or, if it does not have one, through other means. (d) Shamar Hope Haven RTC may redact specific material from the reports when publication would present a clear and specific threat to the safety and security of a facility but must indicate the nature of the material redacted.


During the months of January 1, 2022, through December 31, 2022, there were no allegations of sexual abuse or sexual harassment reported.



Re: The Executive Director and PREA Coordinator does comply with PREA National Standards


§ 115.389 Data storage, publication, and destruction. (a) Shamar Hope Haven RTC shall ensure that data collected pursuant to § 115.387 are securely retained. (b) Shamar Hope Haven RTC shall make all aggregated sexual abuse data, from facilities under its direct control and private facilities with which it contracts, readily available to the public at least annually through its website or, if it does not have one, through other means. (c) Before making aggregated sexual abuse data publicly available, Shamar Hope Haven RTC shall remove all personal identifiers. (d) Shamar Hope Haven RTC shall maintain sexual abuse data collected pursuant to § 115.387 for at least 10 years after the date of its initial collection unless Federal, State, or local law requires otherwise.
